Annual Joint Seminar and Meeting: Appraisers & Assessors

2022 Updates, Changes for Southern NJ Appraisers and Assessors



On Wednesday, April 27, over 60 appraisers and assessors gathered

together on Zoom for our annual joint meeting. Our topics for the event were are follows:

Tax Court Updates, Changes: Judge Mala Sundar, PJTC, discussed tax court issues & recent cases from across the state. Her insight and experience was a great benefit to all. Environmental Updates, Changes: Michael Lucy and Marnie Niederhofer (pictured above) from Water's Edge Environmental, LLC, addressed current local environmental issues, including those dealing with the Tidelands, Wetlands, and Pinelands.

Residential Updates, Changes: Eugene A. Soda, Jr., Vice President, Valuation, WSFS Bank, discussed the new desktop products and their anticipated impact. Bifurcated/Hybrid appraisals was also discussed, as well as new technologies.

After the seminar, Chapter President Joseph Heenan, MAI, SRA, led a chapter meeting. Our traditional book give-away still occurred, despite the virtual location. Books were won (and mailed) to Deb Tordella, MAI, SRA, and Darlene Campbell from the Camden County Assessor's Association. Future education offerings, as well as other chapter and national information, was presented. The 2022 Scholarships were also awarded; more information on that can be found later in this newsletter.

It was noted that in 2021, we held a total of 83 education hours over Zoom. In 2022, we have already offered 43 CE hours, and there are already 22 more hours scheduled, not including the 30 hour course Valuation of Conservation Easements being held in November. You never have to take education anywhere else but with the Southern NJ Chapter!

The remainder of the chapter dinner meetings in 2022 will be in person – September 22 at Top Golf in Mount Laurel, and October 27 at the Adelphia, with the installation dinner event being held December 6 at Terra Nova. Watch for more information on these events!

From the Appraisal Foundation

The Appraisal Foundation's boards and staff have been closely analyzing the Interagency Task Force on Property Appraisal and Valuation Equity (PAVE) action plan since its release in March, and much of our ongoing work aligns with the report's recommendations. These efforts include:

- Working closely with federal regulators and leading voices in the fair housing community to conduct a comprehensive review of the Ethics Rule contained in the *Uniform Standards of Professional Appraisal Practice* (USPAP) and examine the 7-Hour USPAP Update Course,
- Retaining Relman Colfax to review all proposed changes to the standards and qualifications produced by The Appraisal Foundation's boards going forward to ensure they are in compliance with fair housing and civil rights laws,
- Forming a new council, the Council to Advance Residential Equity, to be composed exclusively of civil rights and consumer advocates, and

 Examining further recommendations made by the National Fair Housing Alliance in their January report commissioned by the Appraisal Subcommittee. A Board of Trustees task force will examine the current composition of the Board as well as the fees assessed to sponsors of the Foundation to determine what changes should be made to promote diversity on the Foundation's three boards.

This is just a continuation of our efforts to promote diversity, equity and inclusion. Ongoing updates will be shared as we progress in this critical work.

From the State of NJ: Scam Alert Individuals Impersonating DCA Investigators

The Division of Consumer Affairs (DCA) is warning all licensed professionals about individuals impersonating DCA investigators, Drug Enforcement Administration (DEA) agents and investigators, New Jersey Drug Control Unit investigators, Federal Bureau of Investigation (FBI) investigators, and other law enforcement personnel, as part of an extortion scheme.

The impersonators are contacting licensees by telephone or letter, stating they are the subject of an investigation. The callers demand money to close the investigation and threaten to revoke the individual's



license. Please be advised that the Division of Consumer Affairs will never demand money or threaten to revoke the individual's license.

Anyone who receives a telephone call from a person purporting to be an investigator seeking money should refuse the demand. We encourage you to report the call to the Federal Trade Commission (FTC) at

FHFA Finalizes Strategic Plan for Fiscal Years 2022-2026

On April 20th, the Federal Housing Finance Agency (FHFA) issued the *FHFA Strategic Plan: Fiscal Years 2022-2026* (Strategic Plan). The Strategic Plan provides a framework that outlines the Agency's priorities for the coming years as regulator of the Federal Home Loan Bank System and as regulator and conservator of Fannie Mae and Freddie Mac (the Enterprises).

The Strategic Plan continues existing priorities and formalizes areas of focus for FHFA and its regulated entities by establishing three goals:

- 1. Secure the regulated entities' safety and soundness;
- 2. Foster housing finance markets that promote equitable access to affordable and sustainable housing; and
- 3. Responsibly steward FHFA's infrastructure.

"The Strategic Plan outlines FHFA's goals over the coming years," said FHFA Acting Director Sandra L. Thompson. "This Plan emphasizes FHFA's commitment to safety and soundness, and will further position FHFA's regulated entities to provide equitable access to affordable and sustainable housing opportunities as the country emerges from the pandemic. The Plan also reaffirms

FHFA's emphasis on making effective use of the Agency's resources, including human capital and financial resources, and on identifying and addressing operational risks to the Agency. FHFA is committed to being transparent as it implements this Plan, and we will continue to seek stakeholder input as the Agency considers policy options."

In February, FHFA released a draft *Strategic Plan* and invited feedback from Congress, stakeholders, and the public over a 30-day period ending on March 11, 2022. The Agency carefully reviewed all input and incorporated recommendations where appropriate.

It is governed by a Board of Trustees which oversees two additional boards, the Appraisal Standards Board and the Appraiser Qualifications Board, responsible for writing the standards and qualifications respectively.

Valuation of Conservation Easements is an advanced course designed for the appraiser who understands the methodology in the approaches to value and is ready to embark on understanding the intricacies involved in one of the most misunderstood and difficult types of appraisals. Over 4 days, this intensive program will familiarize participants with conservation easement valuations in a variety of situations, including conventional appraisals, appraisals that are required to comply with the *Uniform Appraisal Standards* of Federal Land Acquisitions, and appraisals involving non-cash charitable contributions that are required to comply with IRS standards. Learning objectives will be accomplished through a series of lectures, in-class discussions, problem solving, homework assignments, and case-law analysis. Objectives:

- Recognize the methodologies and techniques commonly used in valuing conservation easements.
- Grasp state, federal, and IRS regulations and requirements relating to conservation easements.
- Identify the range of assignments that are common in valuing conservation easements.
- Develop an effective scope of work for a conservation easement valuation assignment and apply concepts of highest and best use analysis to that assignment.
- Apply a range of techniques to effectively carry out a conservation easement valuation.
- Identify the unique issues that may apply to conservation easements and complete the assignment(s) in accordance with the various state and federal agency requirements.
