# **Seminars Brought Nationally Known Presenters to Atlantic City**

On September 13 & 14, the Southern NJ Chapter of the Appraisal Institute held its 17<sup>th</sup>e Annual Seminars at the Shore at the Golden Nugget in Atlantic City.

The seminars featured Ted Whitmer, MAI, AI-GRS, who presented "Attacking and Defending an Appraisal in Litigation" on Wednesday. The following day, Randall Bell, PhD, MAI, and Michael Tachovsky, PhD,



presented "Critical Thinking and Junk Science."

In "Attacking & Defending an Appraisal in Litigation," Mr. Whitmer provided a framework and considerations for attacking and defending an appraisal in litigation.

Common mistakes made in appraising and testifying concerning an appraisal were stressed. Various

standards and ethical rules that are frequently misapplied or misunderstood were highlighted and explained. In addition, common tricks and how to prepare for tricks on cross-examination were identified, as well as answering hypothetical questions at trial. A case study was used to apply the Attacking & Defending Model.

The "Critical Thinking & Junk Science" seminar included both principles and case studies for the appraisal professional.



The three approaches to value (cost, income and sales comparison), coupled with complex issues set forth in USPAP AO-9 (cost, use and risk effects) established a solid valuation framework. Understanding these complexities helps develop a credible opinion of value. While many of these issues are addressed throughout USPAP, professional literature and coursework, this course focused on them in a single framework.

Ted Whitmer, MAI AI-GRS CRE CCIM AOB is a Certified USPAP Instructor, served on the TALCB, and was vice chairman of the Board. Ted is a Certified General Appraiser, licensed as a lawyer with the State of Texas and as a Real Estate Broker. He passed the Texas bar in 1988. Previous experience includes teaching every required course in the Appraisal Institute towards the MAI designation, authoring and teaching the Comprehensive Appraisal Workshop as a review for the comprehensive examination for the MAI designation and previously teaching Standards & Ethics, including USPAP. In addition, Ted has authored and instructed many seminars for continuing education including Attacking & Defending an Appraisal in Litigation, which is given to appraisers. lawyers and government employees associated with Boards and other state and federal agencies. In addition to teaching, Ted has extensive experience in consulting including advising in cases with appraiser board enforcement, criminal fraud and civil liability

issues. Past experience in consulting, teaching, serving on the TALCB, and having extensive knowledge of appraisal issues, theory and USPAP make Ted uniquely qualified to represent appraisers.

Institute, following previous positions as vice president, treasurer and secretary, and three years on the chapter's board of directors. He has also served on and chaired Review & Counseling and Experience Review committees in addition to volunteering as a national experience screener and twice participating in the Appraisal Institute's Leadership Development and Advisory Council conference (LDAC). He served as one of the founding members of the steering committee for the Coalition of Pennsylvania Real Estate Appraisers and has served as the organization's treasurer since its inception in 2012. The coalition was formed by the Appraisal Institute's Pennsylvania chapters and other interested appraisal professionals to monitor and weigh in on relevant legislative actions at the state level that affect the valuation community and the public.

In 2016, Mignogna received the Felice A. Rocca Jr. Award and in 2017 the Harrison-Winder Award, both presented by Al's Philadelphia Metropolitan Chapter. The Rocca award was created to honor a distinguished chapter member with "a high sense of ethical behavior on a personal and professional level" and is presented to recipients "who exhibit these qualities." The Harrison-Winder Memorial Award is presented in memory of two long-time appraisers "for all their efforts in advancing the appraisal profession."

After serving two years as the Metro Philadelphia Chapter's representative to Region VI, Mignogna was elected by the region to serve as its 2016 third director, moving on to the national Board of Directors from 2017 through 2020 as vice chair then chair of Region VI. While on the Board, he was elected to the Professional Liability Insurance Program Committee, serving as its chair in 2019 and 2020. He was twice elected to two-year terms on the Audit Committee (2020-2023), serving as vice chair in 2021, chair in 2022 and vice chair again in 2023.

# PAREA: Practical Applications of Real Estate Appraisal --Registration is Open

On September 12, the Appraisal Institute announced that the organization's Practical Applications of Real Estate Appraisal program (Al PAREA) for the licensed residential path has launched broadly, and registration is now open.

The Appraisal Foundation's Board of Trustees awarded the Pathway to Success Grant to the Appraisal Institute to assist with the development of the PAREA program. The Pathway to Success Conditional Grant is designed to open up the appraisal profession to a new generation of appraisers and stipulates that participant priority be given to veterans, minorities and those in designated rural areas. Al was awarded the full grant amount of \$500,000 to build its AI PAREA program in collaboration with its partners. Al committed more than \$2 million toward AI PAREA.

After receiving approval from the Appraiser Qualifications Board in May, AI PAREA initially welcomed select participants who had completed their Qualifying Education & reside in a state which has fully accepted PAREA in lieu of the traditional supervisor/ trainee model during the pilot program phase.

Al PAREA, which is an online program, is an alternative pathway for aspiring appraisers to gain their required experience hours to become a licensed or certified appraiser, using a standardized approach. Historically, the only option for an appraiser to complete their experience hours was through a supervisor/trainee model that requires the aspiring appraiser to find their own supervisor. With the Al PAREA program, participants can appraise properties virtually with one-on-one guidance from a mentor who is an Appraisal Institute Designated Member to help navigate the path to credentialing. Each mentor will answer questions, offer constructive feedback and help participants to develop the problem-solving skills necessary throughout an appraiser's career.

"The AI PAREA program will create tremendous opportunities for aspiring appraisers to meet the experience requirements and open a pathway to entering this respected and rewarding profession,"

said Appraisal Institute President Craig Steinley, MAI, SRA, AI-GRS, AI-RRS. Key elements of AI PAREA:

- Participants will be supported throughout the program by mentors with years of real-world experience who are Appraisal Institute Designated Members and full-time employees of the organization. The Appraisal Institute specifies rigorous requirements for Designated membership regarding experience, education and moral character and those individuals demonstrate the highest standards of education and ethics.
- AI PAREA participants will have access to the organization's 66 chapters to enhance networking opportunities & connect with appraisers who can potentially help participants become geographically competent, meaning participants can learn about the specifics of local markets from appraisers with that knowledge & experience.
- In addition to the basic specification of three Uniform Standards of Professional Appraisal Practice (USPAP)-compliant reports established for PAREA programs by the AQB, AI PAREA features an additional 10 practice assignments and reports. The assignments are consistent for all participants and include a variety of complexity and property types to reinforce important appraisal concepts and skills.
- Assignments that are part of AI PAREA are developed by an organization with a 90+ year history of creating best-in-class education, publications & other appraisal products.
- AI PAREA participants have access to a knowledge center that includes a variety of resources that appraisers use every day including forms software, cameras, GIS, measuring and sketch tools, data services and a multiple listing service (MLS).
